

Commerzbank Annual General Meeting Voting on proposals contained in the agenda May 3, 2017

A total of 621,572,117 shares with an equal number of voting rights or 49.63% of the share capital was represented at the AGM. In addition, 383,174 votes by absentee ballot were cast. In total, 49.66% of the statutory share capital was represented at the AGM.
