April 30, 2024

At the AGM 304 shareholders and shareholder proxies were represented by the voting right representatives of the company. In total they represented 492,460,641 shares resp. voting rights. In addition, 202,833,008 votes by absentee ballot were cast. In total, around 56.06% of the statutory share capital was represented at the AGM.
